- A master plan for the entire institutional complex with the details of the plinth area, including area of laboratories, class rooms, drawing halls, workshops, library, administrative block, hostel etc.
- Proof of temporary/permanent accommodation along with lay out plan and photographs of the premises where the applicant proposes to start the institute.
 - A processing fee of Rs. 50.000 (Fifty Thousand only) in the form of a Demand Draft in favour of the concerned Regional Officer.

You are requested to fulfill all the requirements indicated above at Sl. No. 1 to 5 at the earliest but not later than March 31, 1998. An Expert Committee of the Council shall visit the proposed institute if the documents submitted are found in conformity with the Regulations.

In addition, it may please be noted that prior to the Expert Committee visit, which is tentatively scheduled in the first week of May 1998, following facilities must be kept in place:

- (a) Classrooms.Laboratories etc. for a minimum of first two semesters as per the Norms of the Council.
- (b) Library with adequate number of books & Journals as per Norms for the first two semesters.
- (c) Computer Centre with required number of terminals for first two semesters as per Norms.
- (d) Identification and consent of atleast 70% staff and Faculty.
- (e) Full Time Director/Principal as per AICTE qualifications.

It is further stressed that if the applicant is not able to fulfill any of the requirements as mentioned above. it shall forfeit its claim for further consideration of the proposal during 1998-99. The Trust/ Society may however submit a fresh proposal again for the subsequent academic year. if it so desire.

Kindly note that this is only a viability letter and not a letter of approval.

INSTRUCTIONS FOR SUBMISSION OF THE JOINT FIXED DEPOSIT

The procedure stipulated by the Council for creating a joint FDR in the name of the Trust/Society and the respective Regional Officer is as follows:

- 1. The applicant Trust/Society shall bring in the bank form from a Nationalised Bank duly signed along with the seal of the authorized signatory on behalf of the Trust/Society to the Regional Officer.
- The Regional Officer shall affix his/her signature with seal on the form.
- The Trust/Society shall create a single Cumulative joint Fixed Deposit in the name of the Trust/Society and Regional Officer, AICTE, (city) for a period of ten years in the Nationalized Bank.
- A declaration from the Bank Manager along with his/her name and seal on Form-A (enclosed) shall be taken after the Fixed Deposit is created.
- The original Joint Fixed Deposit Receipt along with the Declaration in Form-A shall be submitted to the Regional Office within the stipulated deadline.



As you are aware, All India Council for Technical Education has been mandated under the AICTE Act, 1987 to ensure maintenance of norms and standards with regard to technical education in the country. In exercise of this mandate, the Council insists on fulfillment of the minimum requirements prescribed for imparting technical education by the institution so that quality of courses is not compromised and stakeholders are satisfied. The Council also undertakes an annual Inspection of the institutions and conveys deficiencies to them for rectification.

It has been observed however that notwithstanding the Council's repeated advice to comply with minimum norms and standards, many institutions continue to be complacent about taking steps to remedy the deficiencies.

Such institutions suffer from critical deficiencies of faculty in proper cadre ratio, qualification, experience and other requirements. Feed back of students with regard to quality of education imparted by such institutions has evoked grave concern. The Expert Committees, following holistic appraisal during inspections, have also pointed out severe shortcomings

The institution has been found to be suffering from several deficiencies, which are listed in Annexure-A for your perusal. Shortage of faculty is of gravest concern.

The deficiencies in respect of faculty (including proper cadre ratio & gualification etc.) could have rendered your institution liable for punitive action including being placed in no admission/ reduced intake category. However the Council has decided to take a lenient view and give you yet another last opportunity to rectify the deficiencies particularly with regard to faculty shortage, proper cadre ratio & requisite qualification. NOTIFICATION

New Delhi, the 12th January, 2007

No. F. 37-3/Legal/2007.—In exercise of the powers conferred by Sub-section (1) of Section 23 read with Section 10 (b), (o) & (v) of the All India Council for Technical Education Act, 1987 (52 of 1987), following Regulations are hereby notified by the Council :

Short title and commencement:-

- (a) These Regulations may be called the All India Council for Technical Education (AICTE) admission of students in Degree Engineering Programmes through lateral entry Regulations 2007.
 - (b) They shall come into force w.e.f. the date of publication in the Official Gazette of India.

(2) Definitions:-

In these Regulations, unless the context otherwise requires,-

- (a) "Act" means the All India Council for Technical Education Act, 1987 (52 of 1987);
- (b) "Commission" means the University Grants Commission established under section 4 of the University Grants Commission Act 1956;
- (c) 'Technical Institution' means an Institution set up by Government, Government Aided and Private (self financing) for conducting courses / programmes in the field technical education, training and research in Engineering, Technology Including MCA, Architecture, Town Planning, Management, Pharmacy, Hotel Management & Catering Technology, Applied Arts & Crafts and such other programmes and areas as are notified by the Council from time to time;
- (d) "University" means a University defined under clause (f) of Section 2 of the University Grants Commission Act, 1956 and includes an institution deemed to be University under section 3 of that Act;
- (e) All other words and expressions used herein and not defined but defined in the All India Council for Technical Education Act, 1987 (52 of 1987), shall have the meanings respectively assigned to them in the said Act;
- (3) Purpose:-

These Regulations provide for admission of diploma holders and B.Sc. graduates into second year degree programmes in Engineering and Technology through lateral entry.

(4) Applicability: -

These Regulations shall be applicable to:

(a) All technical institutions of Govt., Govt. Aided and Private (Self financing) conducting courses / programs in the fields of technical education, training and research in Engineering, Technology including MCA. Architecture, Town Planning, Management, Pharmacy, Hotel Management &

Catering Technology, Applied Arts & Crafts and such other programs and areas as are notified by the Council from time to time.

(b) Universities including Deemed to be Universities of Government, Government Aided and Private (self financing) conducting courses / programs in the fields of technical education, training and research in Engineering, Technology including MCA, Architecture, Town Planning, Management, Pharmacy, Hotel Management & Catering Technology, Applied Arts & Crafts and such other programs and areas as are notified by the Council from time to time.

(5) Requirement: -

Under section 10 (o) of AICTE Act, it shall be the duty of the Council to take all such steps as it may think fit for ensuring coordinated and integrated development of technical and management education and maintenance of standards and for the purposes of performing the functions under this Act, the Council may provide guidelines for admission of students to technical institutions and Universities imparting technical education.

6.1 ADMISSION OF DIPLOMA HOLDERS INTO SECOND YEAR DEGREE ENGINEERING PROGRAMES THROUGH LATERAL ENTRY

6.1. (a) Admission of Diploma Holders

Although engineering diploma programmes are conceived as terminal in nature, some flexibility has to be built in to enable the meritorious amongst diploma holders to obtain Engineering degrees. There is evidence of diploma holders pursing an Engineering programme having performed well not only in their academic careers but also in their jobs.

6.1 (b) Eligibility

For being eligible to seek lateral entry to an Engineering degree programme at the second year/ third semester level, a candidate must have passed the diploma in Engineering in the relevant branch with a minimum of 60 percent in the aggregate. Only candidates fulfilling these conditions would be eligible for appearing in the entrance test meant for selection of diploma holders for Lateral entry to degree programmes. The selection of candidates will be based on an entrance test, the merit ranking in the test being the basis of admission.

At present students obtain diploma through different programmes in different States/UTs. Such programmes have different structures and forms like the semester pattern, annual pattern, sandwich pattern, etc. In order to maintain uniformity, a common entrance examination seems essential. Further, it is necessary to select only meritorious students who have passed the diploma with good academic record.

A student who has acquired a diploma in Engineering through a minimum of three years of institutional study, after 10+(Secondary School Leaving Certificate Examination) can be considered to be academically equivalent to a student who has passed the first year of the four year Engineering degree programme for which the qualifying examination is of the 12+ level.

The Affiliating University may prescribe compensatory courses to make up deficiencies for diploma holders, who are admitted through lateral entry.

6.2(a) Admission of B. Sc,. Graduates

Science education in the country is suffered primarily due to lack of employment opportunities after completion of degree courses. This trend is affected the science education in the country and only a few students are opting to go for the science stream. In order to provide science

students avenues for proper employment opportunities after completing graduation, Science graduates may be permitted to join Engineering courses at second year along with the diploma holders through lateral entry.

6.2 (b) Eligibility:

For being eligible to seek lateral entry to an Engineering degree programme at the second year/ third semester level, a candidate must have passed the Degree in Science (B.Sc.,), with Mathematics as a subject and with a minimum of 60 percent marks in the aggregate. Only candidates fulfilling these conditions would be eligible for appearing in the entrance test meant for selection of B.Sc., graduates for Lateral entry to an Engineering degree programme. The selection of candidates will be based on an entrance test, the merit ranking in the test being the basis of admission.

The affiliating University may exempt B.Sc., degree holders form Science courses and other relevant courses at the second year level and prescribe compensatory courses to makeup deficiencies.

(7) Extent of Lateral Entry

Diploma holders and B.Sc Degree holders shall be eligible for admission to second year Engineering degree programmes up to a maximum of 10% of sanctioned intake, which will be over and above the approved intake (supernumerary). In addition, these candidates shall be eligible for admission in the second year against the vacant seats at first year level. The concerned Admission Authority shall decide the ratio between the diploma holders and B.Sc graduates for admission.

(8) Interpretation

If any question arises as to the interpretation of these Regulations, the same shall be decided by the Council.

The Council shall have the power to issue clarification to remove any doubt which may arise in regard to implementation of these Regulations.

(9) Power to relax

The Council may, in exceptional cases, for removal of any hardship or such other reasons to be recorded in writing, relax any of the provisions of these Regulations.

Sub: Instructions to be issued to the Technical Institutions, Universities including Deemed to be Universities imparting Technical Education regarding matters concerning charging of fees, refund of fees and other student related issues.

Sir,

You are aware that All India Council for Technical Education (AICTE) has been empowered *interalia* under section 10 (n) of AICTE Act to "take all necessary steps to prevent commercialization of technical education". In compliance with the provisions under AICTE Act and in the light of directions of Govt. of India issued under section 20 (1) of AICTE Act vide Letter No. (U.1 (A) Section), it has been decided to issue instructions to the Technical institutions, Universities including Deemed to be Universities imparting Technical Education in the matters concerning students.

Whereas it has come to the notice of the AICTE that Technical Institutions and Universities including Deemed to be Universities, are admitting students to technical education programmes long before the actual starting of an academic session; collecting full fee from the admitted students; and, retaining their school/institution's leaving certificates in the original;

And Whereas, Institutions and Universities are also reportedly confiscating the fee paid if a student fails to join by such dates;

And, Whereas, certificates in original are being detained by institutions and Universities to force retention of admitted students;

To,

And, Whereas the time-limit for students to join the courses/programmes is also being advanced in some cases unrealistically so as to pre-empt students/candidates from exercising other options of joining other institutions of their choice.

In the event of a student/ candidate withdrawing before the starting of the course, the wait listed candidates should be given admissions against the vacant seat. The entire fee collected from the student, after a deduction of the processing fee of not more than Rs.1000/- (Rupees one thousand only) shall be refunded and returned by the Institution/ University to the student/candidate withdrawing from the programme. It would not be permissible for Institutions and Universities to retain the School/Institution Leaving Certificates in original. Should a student leave after joining the course and if the seat consequently falling vacant has been filled by another candidate by the last date of admission, the Institution must return the fee collected with proportionate deductions of monthly fee and proportionate hostel rent, where applicable.

Any violation of instructions issued by the AICTE, shall call for punitive action including withdrawal of approval and recognition of erring institutions and Universities. AICTE shall on its own or on receipt of specific complaints from those affected take all such steps as may be necessary to enforce these directions.

CHAIRMAN'S REPORT

Gudlavalleru Engineering College is located at Gudlavalleru Vilage, Krishna District, A.P.. The promoter society "Adusmilli Aswardha Narayan Murthy & Vallurpali Venkata Rama Seshadri Rao Educational Society" was established on 31st March, 1981 with the object of establishing Aiding and Maintaining technical, engineering and general educational institutions. The Society started "A.A.N.M. & V.V.R.S.R.P.Polytechnic in 1981 and an English Medium School in 1988. The Society has started the Engineering college in 1998. The college is approved by AICTE, permitted by the Government of A.P., and is affiliated with JNTU, Hyderabad.

The college submitted proposals to the NBA for accreditation for following branches of Engineering, U.G. programmes; EEE, ME, ECF, CSE & IT.

Over and above U.G. programmes, it runs MCA(60), MBA(60) and M.Tech. in ECE (18) programmes.

The team comprising of ten experts and myself visited the college on 22nd, 23nd & 24th February, 2008 (List attached). All programmes are AICTE approved and college is affiliated to JNTU.

The Institute is spread over in 25.04 Acre of land with construction area of about 2 Lac 60 thousand sq. ft. The building is spacious & well-planned.

The college has well defined Vision and Mission statements.

The Governance System is in place. Governing Body meetings are regularly held. However decentralization upto faculty level is required.

The Management is committed and are putting efforts to impart the quality education. However the team observed that to some of the fresh recruitees though they are paying basic pay as per AICTE norms for initial some period they do not pay full D.A. as per State Government rules.

There is no Boys Hostel on the campus however Ladies Hostel is available with adequate facilities.

College has a very good library facility in terms of Space, Books, Journals, CDs, etc. Each department also has the Departmental Library. Central Computing facility is quite adequate. The college has 2 mbps internet

bandwidth. Out of total 760 computers, 210 computers are with internet facility. The computers are Wi Fi Enabled.

The faculty is well qualified and committed. The college being in rural area, they have cordial relationship with each other and also with the students. However, students mostly are from the nearby village areas and hence their aspiration level is not very high.

The Department wise strengths and weaknesses observed by the experts is as under :

1. Electrical & Electronics Engineering (U.G.) :

Strengths :

- HOD is a dynamic leader and leads the department in a progressive manner.
- Conducive Environment to pursue the academic activities
- Well equipped laboratory and good Laboratory Manual.
- Good Innovative projects are done under the head of "Mini Projects".
- Faculty Student Ratio & Cadre Ratio is good.

Weaknesses :

- Professors do not possess AICTE qualifications.
- Industry Institution Interaction needs to be improved.
- Thrust on R&D activity & Faculty publication need to be strengthened.
- Placement Activity needs to be strengthened.
- Students need to be encouraged for appearing in Competitive Examinations.

2. Computer Science & Engineering :

Strengths :

Laboratories are well maintained and has adequate floor area.

- Faculty members are working with commitment.
- Good number of supporting staff with adequate qualifications are available.
- Even though the institute is located in rural area quality of student is good.

Weeknesses :

- The department has some P-II, RRIII systems, this needs upgradation or to be removed:
- In some Basic Laboratories, teaching is imparted on DOS which is required to be on Windows base.
- Existing internet bandwidth of 2 mbps should be enhanced.
- Faculty members with B.E./B.Tech. be deputed for P.G. programmes and extra efforts to recruit faculty with P.G. qualification required.

3. Communication Engineering :

Strenaths :

- The department has well-qualified faculty and Cadre Ratio is also maintained.
- Performance Appraisal is carried out through students feed back and proper follow up action is done.
- Faculty is encouraged to improve qualification.
- Supporting staff is well qualified and is as per AICTE norms.
- Meritorious students seek admission in spite of remote location.
- Good Course files and Lab Manuals.
- · Laboratories are well equipped and equipments are well utilized.
- Lecture CDs from I.I.T. faculty being used.

 Handouts are prepared by faculty which enable students to prepare their subjects well.

Weakness :

- Decentralization has to penetrate up to faculty level extent.
- Skill up gradation of technical support staff need enhancement.
- Students should be encouraged to actively involve in professional society activities such as IEEE, IEE, etc. More Entrepreneurship programmes need be organized.
- Industry interaction and Alumni activities also need upgradation.
- Sponsored/Industrial Research & Development need to be enhanced.
- Consultancy & Testing does not exist in the department.

Mechanical Engineering :

Strengths :

- Department has gualified and committed faculty.
- Mechanical Engg. Is a preferred branch for admission by students.
- Department gets allocation of enough recurring and non-recurring budget, and it is utilized.
- Enough number of supporting staff is available for upkeep of the labs/workshops. Efforts are taken for their skill upgradation.
- Students are a happy and satisfied lot.
- Cordial relation exists amongst faculty, supporting staff and students.

Weakness :

 Faculty needs to undertake consultancy / R&D projects. They should then publish papers from the R&D work. At the moment, one or two faculty have publications to their credit. Others also need to be doing this.

- More efforts need to be undertaken towards improvement of communication skill of students.
- More industrial oriented problems need to be given to final year students for their project work

5. Information Technology :

Strengths :

- Department has qualified and dedicated faculties & staff with adequate cadre ratio and Faculty Student ratio. Promotion policy and performance appraisal system exist in the department.
- Faculty participation in various activities of the Department are good.
- Student admissions in the department are as per norms and Academic results of the Department are good. Student Feedback system exists.
- Academic calendar is well maintained and delivery of syllabus content are adequate. Continuous evaluation process in the Department exists.
- Department has well equipped laboratories with adequate number of PCs and licensed software.
- It has a good department library and has online access facility to Institute Library.
- Budget allocation under R&D head exists.

Weaknesses :

- All the faculties of the department do not have individual PC and access to internet.
- Faculty qualifications regular upgradation through more liberal deputation policy
- Supporting Staff in the department don't have opportunity for skill upgradation.

- Participation in competitive exams by students needs to be encouraged.
- Student placement activity needs to be improved.
- Contents beyond syllabus coverage need to be strengthened further.
- Initiative towards R&D activities like Industrial R&D, Industry Participation, Continuing education & Consultancy & Testing need to be improved.

RECOMMENDATION :

The Committee recommends to accredit all programmes as per programme wise marks allocation.
